[Uranium Participation Corp.](#) (TSX:U) ("UPC") reports its estimated net asset value at January 31, 2016 was CAD\$729.5 million or CAD\$6.31 per share. As at January 31, 2016, UPC's investment portfolio consisted of the following:

On January 29, 2016, the common shares of UPC closed on the TSX at a value of CAD\$5.07, which represents a 19.7% discount to the net asset value per share of CAD\$6.31.
