

Subiaco, Western Australia (FSCwire) - [RTG Mining Inc.](#) (TSX: RTG, ASX: RTG) (&#8220;RTG&#8221; or the &#8220;Company&#8221;) is pleased to announce that it has successfully completed the issue of approximately 33 million shares at a price of A\$0.60 per share to institutional and sophisticated investors pursuant to the private placement announced by the Company on 15 July 2016 (&#8220;Private Placement&#8221;). The Private Placement raised proceeds of circa US\$15 million (before costs).

The shares issued pursuant to the Private Placement to subscribers in Canada are subject to a four month and one day hold period under applicable Canadian securities laws.

The Private Placement was led in Australia by Hartleys Limited and co-managed by Taylor Collison and co-led internationally by BMO Capital Markets, together with a syndicate of agents including Tectonic Advisory Partners (acting through Ecoban Securities Corporation), Arlington Group Asset Management Limited and Raymond James.
