Larry was appointed the Company's interim CEO in June 2015 and has served as CFO since January 2010. The Board of Directors has authorized granting of incentive stock options to certain employees and directors of the Company to acquire an aggregate of 3,850,000 common shares of the Company. The options have an exercise price of \$0.16 per share, exercisable until September 23, 2021. The foregoing is subject to regulatory acceptance.

The Company has not granted any stock options since April 23, 2012. The current grant represents 1.8% of total common shares issued and outstanding.
