

The Board of Directors of Exxon Mobil Corporation (NYSE:XOM) today declared a cash dividend of 75 cents per share on the Common Stock, payable on December 9, 2016 to shareholders of record of Common Stock at the close of business on November 10, 2016.

This fourth quarter dividend is at the same level as the dividend paid in the third quarter of 2016.
