(collectively, the Agents"), pursuant to which Ascot will complete a brokered private placement of a minimum of 2,750,000 "flow-through" common shares ("FT Shares") on a guaranteed basis at a price of \$2.25 per FT Share, to raise aggregate minimum gross proceeds of \$6,187,500 (the "Private Placement").
