

# Forrester Metals Inc. Receives Court Approval for Plan of Arrangement

TORONTO, April 27, 2017 - [Forrester Metals Inc.](#) (the "Company" or "Forrester") (NEX: VEM.H) is pleased to announce that the Ontario Superior Court of Justice has issued a final order approving the Plan of Arrangement with [Zinc One Resources Inc.](#) ("Zinc One"), pursuant to which Zinc One will acquire all of the issued and outstanding common shares of Forrester (the "Arrangement"). The Arrangement is subject to Zinc One completing a private placement financing of \$10,000,000. Upon this condition precedent being fulfilled and following receipt of TSX Venture and NEX approval for the transaction, the transaction will close.
