

Durango Resources Fraction East of GGI Positioned for Discovery

Vancouver, December 8, 2017 - [Durango Resources Inc.](#) (TSX.V-DGO), (the "Company" or "Durango") is pleased to announce that further to its news releases dated September 7th and October 13th, 2017, Durango owns 100% of fractional claims that run north south of the length of the Garibaldi Resources Corp. (TSX.V-GGI) claim boundary that is due east of the Discovery Zone.

GGI has announced today, December 8, 2017, that "...Discovery hole EL-17-14, collared 200 meters east of the historic E&L deposit (Discovery Zone) ... belongs to a different massive sulphide lens relative to the massive sulphide interval from hole EL-17-04...". Additional information stated "... that three massive sulphide lenses have been encountered...." and "the massive sulphide zones have not been delimited in any way."

Concurrently, Durango is evaluating the acquisition of another fractional claim adjacent to [Metallis Resources Inc.](#) (TSX.V-MTS), which is adjacent to the east of MTS and southeast of the GGI Discovery Zone land package.
