

Santacruz Commences Drilling at Veta Grande Project

VANCOUVER, Jan. 24, 2018 /CNW/ - [Santacruz Silver Mining Ltd.](#) (TSX.V:SCZ) (the "Company" or "Santacruz") reports Carrizal Mining, S.A. de C.V. ("Carrizal") has initiated a 6,000-meter surface diamond drilling campaign at the Veta Grande located in Zacatecas, Mexico pursuant to the terms of the binding LOI (the "Carrizal LOI") between the Company and Carrizal Mining, press release dated December 14, 2017).

The initial 6,000-meter campaign over 15 drill holes will be focussed on drilling the Veta Grande vein at depth below the level being mined by the Company and is expected to also intersect the La Flor, San Jose and Armados veins that run parallel to the Veta Grande vein.

Carlos Silva, COO of Santacruz, stated "This drill program will allow Santacruz to establish a maiden resource estimate for the Veta Grande vein in the first half of 2018," Mr. Silva continued "Following this Phase 1 program the Company's plan is to continue the exploration program along the northern strike of the Veta Grande vein as we are eager to test the strike extent of the historical vein system."

About Santacruz Silver Mining Ltd.

Santacruz is a Mexican focused silver company with two producing silver projects (Rosario, including the Cinco Estrellas and Membrillo Prospect, and the Veta Grande project and milling facility); and two exploration properties including the Madero property and Zacatecas properties. The Company is managed by a technical team of professionals with proven track record in developing, operating and discovering silver mines in Mexico. Our corporate objective is to become a mid-tier silver producer.
