The date of the Company's 2018 AGM has now been confirmed for 11:00am on 15 May 2018, at the Royal Institute of Chartered Accountants, 21 Albemarle Street, London, W1S 4BS. A full Notice of AGM will be published and circulated to shareholders in due manner and timetable.

As the date of the AGM is later than previously envisaged, there are slight modifications required to the dividend timetable in respect of the 2017 final dividend.

This is due to the final dividend being dependent upon prior approval of shareholders and, therefore, moving the record date to 18 May 2018 will ensure the dividend is declared without any conditions as per the TSX rules.

The following table compares the revised dates to those previously disclosed in the 2017 Trading Update published on 22 March 2018. There are no changes to the amounts being recommended.
