

# Arbitration Update - Suspension of Proceedings Lifted

London, England (FSCwire) - [Gabriel Resources Ltd.](#) ("Gabriel" or the "Company") announces that Professor Pierre Tercier has been appointed in succession to Ms. Teresa Cheng as President of the tribunal ("Tribunal") which will hear and determine the Company's ICSID arbitration claim against Romania ("ICSID Arbitration").

Following the appointment, the Secretary-General of ICSID has notified the parties that the suspension of the ICSID Arbitration proceeding has been lifted in accordance with the ICSID Arbitration Rules. The Company will make further disclosure in regard to the effect of the suspension on the procedural calendar for the ICSID Arbitration, if any, as matters are clarified.

Gabriel is a Canadian resource company listed on the TSX Venture Exchange. The Company's principal focus has been the exploration and development of the RoÅ&Yuml;ia MontanÅ&fno; gold and silver project in Romania. The RoÅ&Yuml;ia MontanÅ&fno; Project, one of the largest undeveloped gold deposits in Europe, is situated in the South Apuseni Mountains of Transylvania, Romania, an historic and prolific mining district that since pre-Roman times has been mined intermittently for over 2,000 years. The exploitation license ("License") for the RoÅ&Yuml;ia MontanÅ&fno; Project is held by RoÅ&Yuml;ia MontanÅ&fno; Gold Corporation S.A., a Romanian company in which Gabriel owns an 80.69% equity interest, with the 19.31% balance held by Minvest RoÅ&Yuml;ia MontanÅ&fno; S.A., a Romanian state-owned mining company. It is anticipated that the RoÅ&Yuml;ia MontanÅ&fno; Project would bring over US\$24 billion (at US\$1,200/oz gold) to Romania as potential direct and indirect contribution to GDP and generate thousands of employment opportunities.

Upon obtaining the License in June 1999, the Group (as defined below) focused substantially all of their management and financial resources on the exploration, feasibility and subsequent development of the RoÅ&Yuml;ia MontanÅ&fno; Project. Despite the Company's fulfilment of its legal obligations and its development of the RoÅ&Yuml;ia MontanÅ&fno; Project as a high-quality, sustainable and environmentally-responsible mining project, using best available techniques, Romania has blocked and prevented implementation of the RoÅ&Yuml;ia MontanÅ&fno; Project without due process and without compensation.
