

Freegold Ventures Limited - Results of the Annual and Special General Meeting

VANCOUVER, June 29, 2018 /CNW/ - [Freegold Ventures Ltd.](#) (TSX: FVL, Frankfurt: FR4N) ("Freegold", the Company) today announced that all matters set out in the Management Information Circular dated May 28, 2018 for the 2018 Annual and Special General Meeting of Shareholders held on June 29, 2018 (the "Meeting") were approved by the shareholders. 77,283,285 shares were voted representing approximately 44.41% of the outstanding shares of the Company.

The following nine nominees were elected as directors of Freegold. The detailed results of the vote for the election of directors are set out below:

The Company's shareholders re-approved the stock option plan.

Kristina Walcott, President & Chief Executive Officer, Gordon Steblin, Chief Financial Officer, Alvin Jackson, Vice President, Exploration & Development and Taryn Downing, Corporate Secretary.

The Board of Directors appointed Gary Moore (Chair), Garnet Dawson, and Ron Ewing as the audit committee and Glen Dickson (Chair), Gary Moore, and Gregory Hanks as the compensation and corporate governance committee and Ron Ewing (Chair), Glen Dickson, and Gary Moore as the nominating committee.
