

Signature Resources Announces Update to its Ongoing Diamond Drill Program of the Lingman Lake Gold Property

TORONTO, Sept. 06, 2018 - [Signature Resources Ltd.](#) (TSXV: SGU, OTCQB: SGGTF) ("Signature" or the "Company") is pleased to announce that six diamond drill holes totaling approximately 600 meters have been completed at its Lingman Lake gold property, located in northwestern Ontario.

The drill program which is being conducted on its patented claims is targeting the known gold zones at various depths and strike intervals. The core from these holes is currently being processed, which includes; total core photography, geotechnical RQD and core recovery, geological logging, sample interval determination and cutting.

"We look forward to receiving the results from the core processing. This is the first time that our technical team will capture information from new core and providing us with observations and sample intervals on whole core", commented Walter Hanych, President and CEO of Signature Resources.

About Signature

The Lingman Lake gold property consists of four free hold patented claims and 762 single cell staked claims. Total land package amounts to 15,372.3 hectares. 275.5 hectares of the property total include 14 mineral rights patents.. The property hosts an historic estimate of 234,684 oz of gold* (1,063,904 tonnes grading 6.86 g/t with 2.73 gpt cut-off) and includes what has historically been referred to as the Lingman Lake Gold Mine, an underground substructure consisting of a 126.5-meter shaft, and 3-levels at 46-meters, 84-meters and 122-meters depths.

*This historical resource estimate is based on prior data and reports obtained and prepared by previous operators, and information provided by governmental authorities. A Qualified Person has not done sufficient work to verify the classification of the mineral resource estimates in accordance with current CIM categories. The Company is not treating the historical estimate as a current NI 43-101-compliant mineral resource estimate. Establishing a current mineral resource estimate on the Lingman Lake deposit will require further evaluation, which the Company and its consultants intend to complete in due course.
