

Grande Prairie's energy community raises more than \$728,000 for the Grande Prairie Regional Hospital Foundation and Grande Prairie Regional College

CALGARY, Sept. 13, 2018 - [Seven Generations Energy Ltd.](#) (TSX: VII), together with business partners, suppliers, service companies, contractors and community members, raised \$728,000 for the Grande Prairie Regional Hospital Foundation and the Grande Prairie Regional College (GPRC) at the annual Seven Generations Energy Charity Golf Tournament last week. This year's fundraising efforts brings the total amount raised to more than \$2.4 million during the last six years.

They are enhancing the vital work of two foundational community institutions and generating positive community outcomes for many years to come. The Grande Prairie Regional Hospital Foundation recently made its first substantial purchase with the funds raised from 7G's Charity Golf Tournament – a bus equipped to transport the residents of Mackenzie Place Continuing Care Centre. The bus provides an opportunity for seniors to travel outside the walls of Mackenzie Place and engage in social and community activities that may now again be part of their daily lives.

"The annual Seven Generations Energy Charity Golf Tournament continues to be the most extraordinary tournament I have had the pleasure of partaking in," said Keith Curtis, Executive Director of the Grande Prairie Regional Hospital Foundation. In a city with a population of more than 68,000, and a community outreach of about 300,000, medical needs for patients continue to increase. The Foundation plays a critical role in funding specialized equipment, major projects, patient care programs and education that would not normally be accessible locally or within the region. GPRC's unique partnership with Alberta Health Services within the new regional hospital on GPRC's west campus land will expand health programming, including the development of state-of-the-art simulation and nursing labs. This partnership has the potential to create new opportunities for initiatives such as joint research, and to increase educational opportunities for all health care staff to better serve northwestern Alberta. New opportunities for GPRC students and faculty to participate in an international exchange are currently in development.
