

Issuance of Incentive Stock Options

LONDON, January 16, 2019 - [Gabriel Resources Ltd.](#) ("Gabriel" or the "Company") announces that it has granted an aggregate of 5,000,000 incentive stock options to certain officers and employees of the Gabriel group of companies in relation to 2018 compensation awards. All incentive stock options so granted are exercisable for a period of ten years at \$0.36 per share and vest as to 50% immediately from the date of grant and 50% on the first anniversary of the date of grant.

As of the date hereof, a total of 29,750,126 common shares of the Company are reserved for issuance under the Company's incentive stock plan, representing approximately 6% of the issued and outstanding share capital.

Gabriel is a Canadian resource company listed on the TSX Venture Exchange. The Company's principal focus has been the exploration and development of the RoÅŸia MontanÄƒ gold and silver project in Romania ("RoÅŸia MontanÄƒ Project"). The RoÅŸia MontanÄƒ Project, one of the largest undeveloped gold deposits in Europe, is situated in the South Apuseni Mountains of Transylvania, Romania, an historic and prolific mining district that since pre-Roman times has been mined intermittently for over 2,000 years. The exploitation license ("License") for the RoÅŸia MontanÄƒ Project is held by RoÈ™ia MontanÄƒ Gold Corporation S.A., a Romanian company in which Gabriel owns an 80.69% equity interest, with the 19.31% balance held by Minvest RoÈ™ia MontanÄƒ S.A., a Romanian state-owned mining company. It is anticipated that the RoÅŸia MontanÄƒ Project would bring over US\$24 billion (at US\$1,200/oz gold) to Romania as potential direct and indirect contribution to GDP and generate thousands of employment opportunities.

Upon obtaining the License in June 1999, the Group (as defined below) focused substantially all of their management and financial resources on the exploration, feasibility and subsequent development of the RoÅŸia MontanÄƒ Project. Despite the Company's fulfilment of its legal obligations and its development of the RoÅŸia MontanÄƒ Project as a high-quality, sustainable and environmentally-responsible mining project, using best available techniques, Romania has blocked and prevented implementation of the RoÅŸia MontanÄƒ Project without due process and without compensation.
