

Argex Titanium Inc. Announces Private Placement

MONTREAL, February 4, 2019 - [Argex Titanium Inc.](#) (TSX: RGX) ("Argex") is pleased to announce that it has received conditional approval from the Toronto Stock Exchange for a private placement of a maximum of 25,000,000 units at a price of \$0.04 per unit (the "Units"), for maximum gross proceeds to Argex of \$1,000,000. Argex expects that a first closing of the private placement will take place on or about February 6, 2019.

Each of the Units will be comprised of one common share and one common share purchase warrant. Each full warrant will entitle its holder to acquire one additional Argex common share at a price of \$0.05 for a period of 24 months.

Argex will use the net proceeds from the sale of the Units for working capital.

The securities to be issued in the private placement will be subject to a four-month "hold period" under applicable securities regulations.
