

LeadFX confirms no material change

PERTH, March 13, 2019 - [LeadFX Inc.](#) ("LeadFX" or the "Company") (TSX: LFX) announces, at the request of IIROC on behalf of the Toronto Stock Exchange, that the Company's management is unaware of any material change in LeadFX's operations that would account for the recent increase in market activity.

InCoR Energy Materials Ltd, one of the Company's controlling shareholders, continues to progress the funding for the closing of the Plan of Arrangement approved by shareholders on October 3, 2018. While discussions related to the timing for funding of the Arrangement are currently ongoing, no definitive announcement of an estimated closing date can be made at this time. The Company will update investors as soon as a closing date can be estimated.
