

Chalice files amended NI43-101 Technical Report

PERTH, Western Australia, March 20, 2019 - [Chalice Gold Mines Ltd.](#) (ASX: CHN, TSX: CXN) ("Chalice" or the "Company") announces, as a result of a review by the Ontario Securities Commission (the "OSC"), it has filed an amended technical report entitled "Technical Report and Mineral Resource Estimate: East Cadillac Gold Project, Val-d'Or, Quebec" dated March 12, 2019 (the "Amended Technical Report").

The Amended Technical Report incorporates non-material changes requested by the OSC and does not change the mineral resource estimate outlined in the original report dated February 12, 2017.
