

# GQ Announces a non-brokered private placement of up to \$500,000

VANCOUVER, April 09, 2019 - [Great Quest Fertilizer Ltd.](#) (TSXV:GQ) ("the Company") is pleased to announce that it intends to carry out, subject to approval from the TSX Venture Exchange (the "TSX-V"), a non-brokered private placement, on a "best efforts" basis, for gross proceeds of up to \$500,000 (the "Private Placement"). The Private Placement will consist of up to 3,333,333 units of the Company (each, a "Unit"), at a price of \$0.15 per Unit. Each Unit shall consist of one common share in the capital of the Company (each a "Share") and one half of a common share purchase warrant. Each whole warrant shall entitle the holder to purchase one common share in the capital of the Company (a "Warrant Share") at a price of \$0.20 per Warrant Share for a period of two years following the closing date. All of the securities issued pursuant to the Private Placement will be subject to a four month and one day hold period from the date of issue.

The funds will be used towards expenses to be incurred with respect to the Change of Business application, currently under review and general working capital expenses.

Subscriptions from participating insiders will be considered to be a related party transaction within the meaning of Exchange Policy 5.9 and Multilateral Instrument 61-101 ("MI 61-101"). The Company intends to rely on the exemptions from the valuation and minority shareholder approval requirements of MI 61-101 contained in Sections 5.5(a) and 5.7(1)(a) of MI 61-101 in respect of any insider participation.
