

IMPACT Silver Announces Financing of \$1 Million

VANCOUVER, June 19, 2019 - [Impact Silver Corp.](#) ("IMPACT" or the "Company") is pleased to announce that it will conduct a non-brokered private placement (the "Private Placement") of up to 3,846,154 units (the "Units") of the Company at the price of \$0.26 per Unit.

Each unit will include one common share in the capital of the Company (a "Share") and one common share purchase warrant (a "Warrant"). Each Warrant will be exercisable into one Share at an exercise price of \$0.30 for 3 years from the date such Warrant is issued.

The Company intends to use the proceeds of the Private Placement to further explore the Zacualpan land package for high potential gold-copper targets such as Santa Teresa and Manto America, Dense Media Separation (DMS) engineering studies on the Capire Volcanic Massive Sulphide resource mill and production center, and ongoing efficiency improvements at the Guadalupe production mill.

It is expected that the closing of the Private Placement will occur in one or more tranches, with the first tranche closing on or about July 24, 2019. The Private Placement is subject to the receipt of approval of the TSX Venture Exchange. The securities issued under the Private Placement will be subject to a hold period of four months and one day from the applicable closing date. The Company reserves the right to increase the size of the Private Placement by up to 20%.

About IMPACT Silver:

[Impact Silver Corp.](#) is a successful silver explorer-producer with two processing plants on adjacent districts within its 100% owned mineral concessions covering 357 km² in central Mexico with excellent infrastructure and a supportive labor force. Over the past fourteen years over 9 million ounces of Silver has been produced, generating revenues of \$168 million, with no long-term debt. In the historic Royal Mines of Zacualpan Silver District three underground silver mines feed the central 535 TPD Guadalupe processing plant. To the south, in the Mamatla District the Capire processing plant is currently rated at 200 tpd, but is expandable. It is adjacent to an open pit silver mine with a NI-43-101 compliant resource of over 4.5 Moz Silver, 48 million lbs Zinc and 21 million lbs Lead (see IMPACT news release dated January 18, 2016) that is awaiting higher silver prices to be restarted. Since acquiring the project, IMPACT has compiled an exhaustive database with over 5,000 old mine workings, assayed over 50,000 rock samples and over 70,000 drill core samples, analyzed over 85,000 soil samples, and put six mines into production.
