Vancouver, August 30, 2019 – [Prime Mining Corp.](#) (TSX.V:PRYM) (the “Company”), formerly EPower Metals Corp. (TSX.V:EPWR) announces that effective at the opening of markets on Wednesday, September 4th, its common shares will resume trading on the TSX Venture Exchange under the ticker symbol “PRYM”. Trading in the common shares of the Company was previously halted, pending acquisition of the rights to earn a 100% interest in the Los Reyes project in Sinaloa State, Mexico. The Company will continue to be classified on the Exchange as a Tier 2 Mining Issuer.
