# Newlox Gold Ventures Corp. - Private Placement

Vancouver, 1 November 2019 - Newlox Gold Ventures Corp. (CNSX:LUX.CN) (Frankfurt: NGO) ("Newlox" or the "Company") announces private placements totalling \$40,000.00 for issuance of 800,000 Units. Each Unit consists of one Common Share of the Company and one Warrant. Each Warrant is non-transferrable and entitles the holder to purchase an additional Newlox common share for C\$0.10 for a period of 2 years.

Newlox has allocated the proceeds of this Private Placement to general administrative working capital and to support commercial operations at the Company's recently commissioned environmental reclamation and precious metals production facility in Central America.

In connection with the closing of the Private Placement, the Company will pay a finders' fee of eight percent and issue eight percent in Finder's Units.

#### Recent News

- Newlox recently shared a video demonstrating the operation of its in-house analytical laboratory. The on-site laboratory has both fire-assay and atomic absorption capabilities, allowing for the sampling and assay of solid and liquid samples for precious metals content. The lab enables the Company to keep strict control of feed grade, operational parameters, and metals produced.
- Newlox marked four months of continuous gold production on October 8, 2019 and shared a second video of gold dore being poured at the environmental remediation and precious metals production facility.
- Newlox posted a video demonstrating one of the many pours during the summer in August of 2019. Pouring of gold dore became a regular procedure for the Company in the summer of 2019, and management commended the operations team on their hard work and dedication.
- Newlox established steady-state operations in June of 2019, as announced on July 9, 2019
- The Company announced it had completed pre-production activities at the plant on May 27, 2019.

Newlox Gold Ventures Corp. is an environmental remediation company recovering contaminants and residual precious metals from historical waste left behind over more than a century of inefficient artisanal and small-scale mining in politically and socially stable jurisdictions in Latin America.

Newlox has signed agreements with local artisanal mining cooperatives to provide both a steady supply of historical tailings and a newly created feedstock for its first fully operational processing plant in Central America.

With hundreds of years of mining history in Latin America and inefficient artisanal processing continuing to this day, the Company has identified and secured a compelling opportunity to grow its business model. Newlox has identified a niche within the extractive industry where a clean-technology company can apply innovative processing techniques to recover not only precious metals but also affect positive change in the environmental and social landscape in its targeted jurisdictions of operations.
