

Pacific Ethanol Pekin Extends Credit Agreements with CoBank

SACRAMENTO, Nov. 15, 2019 - [Pacific Ethanol Inc.](#) (NASDAQ: PEIX), a leading producer and marketer of low-carbon renewable fuels and high-quality alcohol products in the United States, reported that Pacific Ethanol Pekin, LLC, an indirect wholly-owned subsidiary of [Pacific Ethanol Inc.](#), has entered into an amendment to extend the waiver and payment deferral terms of its credit agreements with CoBank, ACB through December 15, 2019.
