

# Bonanza Creek Energy Announces Results of Borrowing Base Redetermination

DENVER, Dec. 02, 2019 - [Bonanza Creek Energy Inc.](#) (NYSE: BCEI) (the "Company" or "Bonanza Creek") today announces that the lenders under its senior secured credit facility have concluded their semi-annual redetermination and reaffirmed the borrowing base of \$375 million and the elected commitments of \$350 million. As of September 30, 2019, the Company had \$80 million drawn on the facility and held approximately \$8 million in cash.

Eric Greager, Chief Executive Officer, commented, "We are pleased that our bank syndicate reaffirmed its commitment to Bonanza Creek. With \$270 million of liquidity, and no other long-term debt, the Company continues to have ample financial flexibility heading into 2020."

As previously announced, members of the Company's management will attend and participate in meetings at Capital One's 14<sup>th</sup> Annual Energy Conference in Houston on December 10-12, 2019.
