Bearing Announces Private Placement Financing

Vancouver, December 10, 2019 - <u>Bearing Lithium Corp.</u> (TSXV: BRZ) (OTCQB: BRGRF) (FSE: B6K1) ("Bearing" or the "Company") is pleased to announce a non-brokered private placement (the "Private Placement") offering of 5,000,000 units ("Units") at a price of \$0.12 per Unit for gross proceeds of \$600,000. The Company will also have the option to increase the size of the Private Placement to 8,333,334 Units, for total gross proceeds of \$1,000,000.

Each Unit will consist of one common share and one-half of a common share purchase warrant (each whole warrant, a "Warrant"). Each Warrant will entitle the holder to purchase one additional common share of the Company at a price of \$0.18 for 18 months following closing of the Private Placement. The Warrants will be subject to an acceleration clause in the event the closing price of the Company's common shares on the TSX Venture Exchange is greater than \$0.30 for 15 consecutive trading days (the "Acceleration Event"). The Company will give notice to the holders of the Acceleration Event and the Warrants will expire 30 days thereafter.

In connection with the Private Placement, the Company may pay cash finders' fees to eligible finders of up to 6% of the gross proceeds received and may issue warrants equal to 6% of the Units placed ("Finders" Warrants"). The Finders' Warrants will have the same terms as the Warrants forming part of the Units.

The Company intends to use the net proceeds of the Private Placement to fund anticipated capital calls of Maricunga Project Joint Venture and for working capital.

Completion of the Private Placement remains subject to the approval of the TSX Venture Exchange. All securities issued pursuant to the Private Placement will be subject to a statutory four month hold period.

Bearing Lithium Corp. is a lithium-focused mineral exploration and development company. Its primary asset is an 18% interest in the Maricunga Lithium Brine Project in Chile. The Maricunga Project represents one of the highest-grade lithium brine salars globally and the only pre-production project in Chile. Over US\$30 million has been invested in the Maricunga Project to date and all expenditures through to the delivery of a Definitive Feasibility Study have been fully-funded by the earn-in joint-venture partner
