

# Bam Bam Resources Corp. Commences Drilling the Majuba Hill Property in Nevada

VANCOUVER, April 29th, 2020 - [Bam Bam Resources Corp.](#) (CSE: BBR / OTC: NPEZF / FSE: 4NPA) ("Bam Bam" or the "Company") is pleased to announce that the Phase 1 2020 drill program is underway at its flagship Majuba Hill Property (the "Property"), a copper, gold porphyry project located in Pershing County, Nevada. The two core holes are planned to aid in expanding the oxide copper-gold mineralization on the Property.

Mr. David Greenway, CEO, commented: "We are glad to be able to begin the drilling at Majuba. Our planning for this project allows us to move forward with drilling that is designed to expand the copper, gold, and silver mineralization identified in the historic data. Majuba is an exciting project and the opportunity to expand the historic zones will strengthen Bam Bam Resources' position as a junior resource company. Our Nevada contractors are able to safely operate within all of the Covid-19 protocols mandated by the Governor of Nevada and the U.S. Federal government."

## Phase 1 Drilling Program

Drilling has begun and is being conducted by Harris Exploration Drilling & Associates Inc. ("Harris") of Fallon, NV, using a track mounted Core Rig. The two initial core drill holes will target the high-grade copper zones containing significant gold and silver that were identified from historic mining and drilling data. Bam Bam field personnel and contractors are using operational health and safety protocols consistent with ensuring the health and safety of its people, the local community, and the State of Nevada.

The drill program is being managed by Bam Bam's Exploration Geologist, E.L. "Buster" Hunsaker III, a Qualified Person as defined by NI 43-101. He is a Certified Professional Geologist (CPG 8137) with the American Institute of Professional Geologist.

## About the Majuba Hill Property

The Majuba Hill Property encompasses 4,822 acres of surface and mineral rights that includes 3 patented lode mining claims and 632 acres of privately owned surface and minerals. The property is easily accessed via 23 miles of well-maintained dirt roads leading from U.S. Interstate 80. Three gold zones are outlined based on the historic data. The gold zone in the main target area overlaps with the oxide copper target zone that will be drilled in the upcoming program.
