

# Anglo Pacific Group PLC Announces Transaction in Own Shares

LONDON, October 7, 2020 - [Anglo Pacific Group PLC](#) ("Anglo Pacific", the "Company" or the "Group") (LSE: APF, TSX: APY), announces that on 6 October 2020, it purchased 122,989 ordinary shares of 2p each in the Company (the "Shares") on the London Stock Exchange through Peel Hunt LLP, in accordance with the terms of its share buyback programme announced on 25 September 2020 (the "Programme"). The shares acquired will be held in treasury.

Following the purchase, the Company will have 181,758,719 ordinary shares of 2p each in issue, of which 904,677 ordinary shares are held in treasury. Therefore, the total number of ordinary shares carrying voting rights will be 180,854,042.

The above figure of 180,854,042 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
