

Victory Metals Announces Closing of Additional Private Placement Offering

VANCOUVER, Oct. 29, 2020 - [Victory Metals Inc.](#) ("TSX-V:VMX") ("Victory" or the "Company") announces it will be closing an additional non-brokered private placement offering, raising gross proceeds of \$200,000 through the issuance of 500,000 common shares in the capital of the Company (the "Shares") at a price of \$0.40 per Share (the "Additional Private Placement"). On October 8, 2020, the Company closed a non-brokered private placement offering, pursuant to which it raised \$2,000,000 by issuing 5,000,000 Shares at a price of \$0.40 per Share (the "Initial Private Placement").

The Additional Private Placement, following the recent completion of the Initial Private Placement, was a response by the Company to satisfy additional interest from investors in its Shares. As with the Initial Private Placement, the net proceeds from the Additional Private Placement will be used to advance the Company's Iron Point Vanadium Project and for general working capital purposes.

In connection with the Additional Private Placement, cash finder's fees in an aggregate amount of \$12,000 payable to an eligible finder are applicable.

All securities to be issued in respect to the Additional Private Placement will be subject to a hold period expiring March 1, 2021, being the date that is four months and one day from the closing date of the Additional Private Placement in accordance with applicable securities laws. Closing of the Private Placement is subject to final acceptance by the TSX Venture Exchange.

About Victory Metals

Victory owns a 100% interest in the Iron Point Vanadium Project, located 22 miles east of Winnemucca, Nevada. The project is located within a few miles of Interstate 80, has high voltage electric power lines running through the project area and a railroad line passing across the northern property boundary. The Company is well financed to advance the project through resource estimation and initial feasibility study work. Victory has a proven capital markets and mining team led by Executive Chairman Paul Matysek. Major shareholders include Palisades Goldcorp (48%), and management, directors and founders (27%).
