## NGX Energy Announces Name Change to NG Energy International Corp. and Update on Pipeline Financing

VANCOUVER, Nov. 12, 2020 - <u>NGX Energy International Corp.</u> (the "Company" or "NGX") (TSXV: GASX) (OTC: GAS announces that effective at the market open on November 16, 2020, the Company will change its name to "NG Energy International Corp."

The new CUSIP number for the renamed company's shares is 62931J102 and the new ISIN number is CA62931J1021 CUSIP number for its warrants is 62931J110 and the new ISIN number is CA62931J1104.

Further to the Company's press release dated October 6, 2020, the Company has agreed with a third party, GTX Internation Corp. ("GTX"), that GTX will build and operate the compression facilities and pipeline to be built from the Company's M Conchita field in Colombia to existing pipelines (the "Pipeline Facilities") pursuant to a memorandum of understanding the entered into between the Company and GTX (the "MOU"). Pursuant to the MOU, the Company, one of its subsidiaries or one of its subsidiaries will enter into a take or pay agreement whereby GTX will process and transport a minimum of cubic feet per day of gas to be delivered to the Colombian National Transportation System. GTX has engaged Canacca Genuity Corp. to act as agent for a US\$10 million brokered debenture financing which is anticipated to close next week "GTX Financing").

The net proceeds of the GTX Financing are anticipated to be used to fund the construction of the Pipeline Facilities.

The Company also announces that further to its press release dated August 19, 2020, in relation with the SN-9 Block e program, the USD\$2.5M secured loan bearing interest at 15% per annum advanced in August 2020 with various related unrelated parties has been approved by the TSX Venture Exchange. The lenders have been granted a 3% royalty on the Company's 72% working interest in gross production from the SN-9 Block and have an option to convert the debt into a overriding royalty on such working interest.

NG Energy International Corp. is a publicly traded E&P company on a mission to provide a clean and sustainable solut Colombia's energy needs. The Company intends on executing this mission by producing and bringing gas to the premic Colombian gas market from its concessions, SN-9, a 311,353 acres block which is adjacent to Canacol's Nelson field, a Maria Conchita, a 32,518 acre block located in the region of La Guajira.
