

# Global Atomic Announces Accelerated Expiry of Common Share Purchase Warrants

TORONTO, Jan. 21, 2021 - [Global Atomic Corp.](#) ("Global Atomic" or the "Company"), (TSX: GLO, OTCQX: GLATF, FRANKFURT: G12) announced the acceleration of the expiry date of common share purchase warrants ("warrants") issued pursuant to the Company's Unit private placement of May 2020.

Units consisted of one common share and one-half common share purchase warrant exercisable at C\$0.85 for a period of two years from closing, Finder's warrants issued pursuant to closing are exercisable at C\$0.67 for a period of two years from closing.

All warrants are subject to accelerated expiry should [Global Atomic Corp.](#) common shares close at or above C\$1.10 on the Toronto Stock Exchange for twenty (20) consecutive trading days and the Company issues a news release announcing the acceleration of term.

The closing price of Global Atomic Common Shares has been at or above \$1.10 for the twenty (20) consecutive trading days during the period December 22, 2020 - January 21, 2021. A total of 2,005,834 Investor warrants and 141,300 Finder's warrants remain outstanding and will generate \$1.8 million on exercise and expire February 22, 2021.

The Company's Uranium Division includes four deposits with the flagship project being the large, high-grade Dasa Project, discovered in 2010 by Global Atomic geologists through grassroots field exploration. With the issuance of the Dasa Mining Permit, final design in support of the Company's Feasibility Study is on-going.

Global Atomics' Base Metals Division holds a 49% interest in the Befesa Silvermet Turkey, S.L. ("BST") Joint Venture, which operates a new, state of the art zinc production plant, located in Iskenderun, Turkey. The plant recovers zinc from Electric Arc Furnace Dust ("EAFD") to produce a high-grade zinc oxide concentrate which is sold to zinc smelters around the world. The Company's joint venture partner, Befesa Zinc S.A.U. ("Befesa") listed on the Frankfurt exchange under 'BFSA', holds a 51% interest in and is the operator of the BST Joint Venture. Befesa is a market leader in EAFD recycling, with approximately 50% of the European EAFD market and facilities located throughout Europe and Asia.
