

Baselode Webinar: Property Criteria for Uranium Deposits

1. Redox fluid properties required for high-grade uranium concentration.

3. A comparison of the Athabasca sedimentary basin's ancient tectonic mountain belt to the Tarim Basin formation within the Himalayan mountain belt. This comparison suggests that Baselode's properties were once underneath sandstones that would have provided soluble uranium within oxygenated fluids for re-deposition and concentration.
