VANCOUVER, March 18, 2021 - [Starr Peak Exploration Ltd.](#) ("Starr Peak" or the "Company") (TSXV: STE) (OTC: STRPF) announces that effective at the market open on Tuesday, March 23, 2021, the Company will change its name to "Starr Peak Mining Ltd." and its common shares will commence trading on the TSX Venture Exchange under its new name. The Company's trading symbol "STE" will remain the same.

The new CUSIP number for the shares is 85562P105 and the new ISIN number is CA85562P1053.
