### 2020 Year-End Reserves

Arrow has also filed, on SEDAR, the Company's Statement of Reserves Data and Other Oil and Gas Information, Report on Reserves Data by Independent Qualified Reserves Evaluator, and Report of Management and Directors on Oil and Gas Disclosure for the year ended December 31, 2020, as required

by section 2.1 of National Instrument 51-101 - Standards of Disclosure for Oil and Gas Activities (together, the "Reserve Report").

To recap, the Company's Year-End 2020 Company Gross Reserves Highlights include:

- 2,930 Mboe of Proved Reserves ("1P Reserves");
- 7,034 Mboe of Proved plus Probable Reserves ("2P Reserves");
- 10,480 Mboe of Proved plus Probable plus Possible Reserves ("3P Reserves")<sup>1</sup>;
- 1P Reserves estimated net present value before income taxes of US\$9.6 million calculated at a 10% discount rate;
- 2P Reserves estimated net present value before income taxes of US\$34.3 million calculated at a 10% discount rate; and
- 3P Reserves estimated net present value before income taxes of US\$63.8 million calculated at a 10% discount rate.

The asset base is predominantly operated with high working interests, and the Brent-linked light oil pricing exposure combines with low royalties to yield attractive potential operating margins. Arrow's 50% interest in the Tapir Block is contingent on the assignment by Ecopetrol SA of such interest to Arrow. Arrow's seasoned team is led by a hands-on executive team supported by an experienced board. Arrow is listed on the TSX Venture Exchange under the symbol "AXL".
