

# Snowy Owl Gold Boots on the Ground at Golden Eagle

Vancouver, June 8, 2021 - [Snowy Owl Gold Corp.](#) (CSE: SNOW) (FSE: 84L) ("Snowy Owl" or the "Company") [Snowy Owl Gold Corp.](#) is pleased to announce that boots are on the ground with the recent arrival of our geological team at the Company's 100% owned Golden Eagle Project. Grassroots exploration activities are currently underway. The goal would be to confirm encouraging data received during the winter in-depth geophysical analysis and geoscientific compilation studies described in the Company's last news release and generate potential future exploration targets.

After completing fieldwork at Golden Eagle, the Company plans to direct the exploration crew to the Panache Gold project, some 30km northwest of the Golden Eagle. Advanced miners such as Osisko and Bonterra Resources hold several gold deposits and occurrences between Snowy Owl's two projects (Figure 1).
