Garrett is currently the managing partner and co-founder of a real estate development company with 20 years of business and financial management experience. Previously, as the CFO, Garrett spent the last 14 years building businesses alongside the founder and CEO of a multi-billion dollar investment enterprise, focused primarily on ranching and energy investments. He has led and promoted multiple process improvement initiatives, system integrations, automation projects, and AI endeavors. Prior to his energy stint, Garrett worked in assurance and advisory consulting services for Ernst & Young. Garrett earned a Bachelor of Science in Business Administration with concentrations in Finance and Accounting from Trinity University. He is a Certified Public Accountant and also holds a Masters of Science in Accounting from Trinity University.

While at D&M, Ms. Light evaluated the oil reserves of several major waterflood projects in Russia and estimated the future deliverability of numerous gas fields important to the gas supply of the Russian Federation. Before joining D&M, Virginia practiced law as an oil and gas title attorney, with a focus on title work in the Barnett Shale. She holds a Bachelor of Science degree in Petroleum Engineering as well as a Minor in Dance from Texas A&M University where

she was a President's Endowed Scholar. Ms. Light received her Juris Doctorate degree from St. Mary's University School of Law where she served on the Editorial Board of the St. Mary's Law Journal. She is a licensed attorney admitted to the State Bar of Texas.
