

GoGold Resources Inc. Announces Closing of C\$46 Million Bought Deal Financing

HALIFAX, March 8, 2022 - [GoGold Resources Inc.](#) (TSX: GGD) ("GoGold" or the "Company") is pleased to announce that it has closed its previously announced bought deal offering (the "Offering") of 16,146,000 common shares (the "Common Shares") at a price of C\$2.85 per Common Share, for aggregate gross proceeds of approximately C\$46 million, including proceeds from the full exercise of the over-allotment option to purchase an additional 2,106,000 Common Shares.

The Offering was led by BMO Capital Markets, along with a syndicate of underwriters including PI Financial Corp., Sprott Capital Partners LP, Desjardins Securities Inc., Eight Capital, and Echelon Wealth Partners Inc. (collectively, the "Underwriters").

The Underwriters were paid a commission of 5.5% on the gross proceeds of the Offering. The net proceeds of the offering are intended to be used to support the continued advancement of the Company's Los Ricos North and South projects.

The Offering was completed by way of short form prospectus in each of the provinces of Canada, except Québec, pursuant to National Instrument 44-101 - Short Form Prospectus Distributions.

The securities offered in the Offering have not been registered under the United States Securities Act of 1933, as amended (the "U.S. Securities Act"), or any U.S. state securities laws, and may not be offered or sold in the "United States" (as such term is defined in Regulation S promulgated under the U.S. Securities Act) absent registration or an applicable exemption from the registration requirements of the U.S. Securities Act and applicable U.S. state securities laws.
