

GoGold Resources Inc. Reports Quarterly Production at Parral of 455,991 Silver Equivalent Ounces

HALIFAX, April 6, 2022 - [GoGold Resources Inc.](#) (TSX: GGD) (OTCQX: GLGDF) ("GoGold", "the Company") is pleased to report production for the quarter ending March 31, 2022 of 455,991 silver equivalent ounces, consisting of 186,655 silver ounces, 2,791 gold ounces, and 125 tonnes of copper.

"Parral continues to provide meaningful cash flow contributing to the general and administrative costs and the Los Ricos exploration budget," said Brad Langille, President and CEO. "Parral continues to be a steady source of cash flow while the Los Ricos project is the major driver of shareholder value for the Company."

The copper: silver ratios were: Dec 2020 - 305, Mar 2021 - 320, June 2021 - 369, Sep 2021 - 383, Dec 2021 - 417, Mar 2022 - 411.
