

Antioquia Gold Cisneros Operations Update

Calgary, April 11, 2022 - [Antioquia Gold Inc.](#) (TSXV: AGD) (OTC Pink: AGDXF) ("Antioquia Gold" or the "Corporation") is pleased to provide a summary of March 2022 production results for its Cisneros mining operation.

Production Summary:

During March, 4,165 troy ounces of gold were produced at the Cisneros mining operation. An average of 1,334 tonnes of ore per day were processed, with a recovery of gold to concentrate of 95.3% during the month.

Third Party Mineralized Material: During March, 3,297 tonnes of mineralized material with an average gold grade of 14.51 g/t were purchased from third parties, representing 33% of the monthly gold production.

"We are very pleased to maintain a stable gold production above 4,000 ounces during the first quarter of the year, which is a very significant achievement. Additionally, in March, we have exceeded 40,000 tons per month in our processing plant for the first time. Congratulations to all team members for these achievements." stated Mr. Gonzalo de Losada, president and CEO of Antioquia Gold.

Readers should be cautioned that the Corporation's decision to move forward with the construction and production of the Cisneros Mine is not based on the results of any pre-feasibility study or feasibility study of mineral resources demonstrating economic or technical viability. Since 2013, the Corporation has undertaken exploration and development activities; and after taking into consideration various factors, including but not limited to: the exploration and development results to date, technical information developed internally, the availability of funding, the low starting costs as estimated internally by the Corporation's management, the Corporation is of the view that the establishment of mineral reserves, the commissioning of a pre-feasibility study or feasibility study at this stage is not necessary, and that the most responsible utilization of the Corporation's resources is to proceed with the development and construction of the mine. Readers are cautioned that due to the lack of pre-feasibility study or feasibility study, there is increased uncertainty and higher risk of economic and technical failure associated with the Corporation's decision. In particular, there is additional risk that mineral grades will be lower than expected, the risk that construction or ongoing mining operations will be more difficult or more expensive than management expected. Production and economic variables may vary considerably, due to the absence of a detailed economic and technical analysis in accordance with NI 43-101. Project failure may materially adversely impact the Corporation's future profitability, its ability to repay existing loans, and its overall ability to continue as a going concern.
