

Foothills Exploration Inc. Commences Drilling Of New Well In The Illinois Basin

LOS ANGELES, July 13, 2022 - [Foothills Exploration, Inc.](#) (OTC: FTXP), including its direct and indirect subsidiaries, ("Foothills," or the "Company"), an oil and gas exploration company focused on delivering the energy needs of today and tomorrow, is pleased to announce commencement of drilling operations for the Houser-Sears #6 well.

"We are pleased to report that our partner, Benchmark Properties, who is operator of the Ste. Marie West Project drilling and development program, has advised us that drilling is now underway at the Jasper, Illinois property. Foothills' direct subsidiary, Anaconda Energy, owns a 50% working interest in the well with the remaining 50% interest divided amongst industry partners," said Kevin Sylla, the Company's Executive Chairman.

Houser-Sears #6 Well

The Houser-Sears #6 well drilling operations commenced yesterday targeting a proposed depth of 3,500 feet. This infield drilling location is in a stacked-pay environment with the potential to produce from several pay zones. The primary objectives are the Aux Vases Sand (2,724'), Upper McClosky Limestone (2,800') and McClosky Dolomites (2,840'). The secondary objectives are the St. Louis Lime (3,150') and Salem Lime (3,308'). If the well is drilled and completed successfully the potential expected payout is within 180-270 days of initial production.
