

# Sandstorm Gold Royalties Announces Record Sales and Revenue in Third Quarter 2022

VANCOUVER, Oct. 6, 2022 - [Sandstorm Gold Ltd.](#) ("Sandstorm Gold Royalties" or the "Company") (NYSE: SAND) (TSX: SGR) is pleased to report that the Company sold approximately 22,600 attributable gold equivalent ounces<sup>1</sup> and realized preliminary revenue<sup>2</sup> of \$38.9 million during the three months ended September 30, 2022, both representing a record for the Company's attributable gold equivalent ounces and \$27.6 million in revenue for the comparable period in 2021). Preliminary cost of production<sup>3</sup> excluding depletion<sup>2</sup> for the three month period was \$7.3 million resulting in cash operating margins<sup>1</sup> of approximately \$20.6 million per attributable gold equivalent ounce<sup>1</sup> (\$3.7 million and \$1,541 per attributable gold equivalent ounce for the comparable period in 2021, respectively).

<p><b>Note 1</b></p> <p>Sandstorm Gold Royalties has included certain performance measures in this press release that do not have any standardized meaning prescribed by International Financial Reporting Standards ("IFRS") including (i) attributable gold equivalent ounces and (ii) cash operating margin. The presentation of these non-IFRS measures is intended to provide additional information and should not be considered in isolation or as a substitute for measures of performance prepared in accordance with IFRS. Other companies may calculate these non-IFRS measures differently. Note these figures have not been audited and are subject to change.</p> <p>(i) As the Company's operations are primarily focused on precious metals, the Company presents attributable gold equivalent ounces as it believes that certain investors use this information to evaluate the Company's performance in comparison to other mining companies in the precious metals mining industry who present results on a similar basis. Attributable Gold Equivalent ounces is a non-IFRS financial ratio that uses Total Sales, Royalties, and Income from Other Interests as a component. Total Sales, Royalties and Income from Other Interests is a non-IFRS financial measure and is calculated by taking total revenue which includes Sales and Royalty Revenue, and adding contractual income relating to royalties, streams and other interests excluding gains and losses on dispositions. Attributable Gold Equivalent ounces is calculated by dividing the Company's Total Sales, Royalties, and Income from other interests, less revenue attributable to non-controlling shareholders for the period, by the average realized gold price per ounce from the Company's Gold streams for the same respective period (<math>[\\$38.9 \text{ million} - \\$0.4 \text{ million}] / \\$1,706</math> average realized gold price for the current period and <math>\\$27.6 \text{ million} / \\$1,779</math> average realized gold price for the prior period) and may be subject to change. (ii) The Company presents cash operating margin as it believes that certain investors use this information to evaluate the Company's performance in comparison to other companies in the precious metals mining industry who present results on a similar basis. Cash operating margin is calculated by subtracting average cash cost per Attributable Gold Equivalent ounce from the average realized gold price per ounce from the Company's Gold streams (see item i above) for the same respective period. Average cash cost per Attributable Gold Equivalent ounce is calculated by dividing the Company's cost of sales, excluding depletion, by the number of Attributable Gold Equivalent ounces (<math>\\$7.3 \text{ million} / 22,600</math> Attributable Gold Equivalent ounces for the current period and <math>\\$3.7 \text{ million} / 15,514</math> Attributable Gold Equivalent ounces for the prior period).</p>

As a foreign private issuer that is eligible to report with the SEC pursuant to the multi-jurisdictional disclosure system, the Corporation is not required to provide disclosure of its mineral properties under the SEC Modernization Rules and will continue to provide disclosure under NI 43-101 and the CIM Definition Standards.
