

SRG Mining Inc. Announces Change of Auditor & Update to the Board of Directors

Montreal, Nov. 2nd, 2022 - [SRG Mining Inc.](#) (TSXV:SRG) ("SRG" or the "Company") announces that it has changed its auditors from PricewaterhouseCoopers LLP ("Former Auditor" or "PwC") to Raymond Chabot Grant Thornton LLP, ("Successor Auditor" or "RCGT"). The Former Auditor resigned as auditor of SRG at the Company's request and the Company appointed the Successor Auditor as the new auditor effective October 24th, 2022.

In accordance with National Instrument 51-102 - Continuous Disclosure Obligations ("NI 51-102"), the Company has filed a Notice of Change of Auditor on SEDAR together with letters from both PwC and RCGT, with each letter confirming agreement with the statements contained in the notice, as applicable. There were no reportable events (as defined in NI 51-102) between PwC and the Company.

In addition, the Company announces that the Board of Directors accepted the resignation of Mr. Nikolaos Sofronis as a member of the Board of Directors.

"We wish to thank Mr. Sofronis for his contribution and regret his departure. We wish him well in all his endeavours." said Mr. Benoit La Salle, Executive Chairman of SRG.
