The reason for the postponement is for additional time to complete certain analyses, documentation and additional procedures to compile and complete the necessary financial information for the first combined period following the previously announced business combination. Noble is not aware of any material inaccuracy in its previously reported results of operations for the period ended December 31, 2022.
