

Inca One Gold Reports January 2023 Gold Sales

Vancouver, March 8, 2023 - [Inca One Gold Corp.](#) (TSXV: INCA) (OTCQB: INCAF) (FSE: SU92) ("Inca One" or the "Company") a gold producer operating two mineral processing facilities in Peru, (the "Plants") reports consolidated sales (unaudited) for January and comparative month over month ("MoM") operational results.

Sales in January reached US\$3.48 million, a slight decrease of 1% from the prior month of December sales of \$3.53 million. Accounting for the small decrease was a lower volume of gold sold (1,779 ounces versus 1,894 ounces) from the prior month of December. Average gold price received was US\$1,909/oz this month, as opposed to US\$1,788/oz in December 2022.

Deliveries in January were 2,427 tonnes to both Plants. Seasonal holidays generally accounted for the lower supply of raw material available for milling this month.

Combined milling activities reached 3,005 tonnes, averaging 97 tonnes per day ("TPD") throughput for the month. Gold production in January reached 1,428 ounces.
