

# NEXA Provides Update on Cerro Lindo Mine Operation

LUXEMBOURG, March 28, 2023 - [Nexa Resources S.A.](#) ("Nexa Resources" or "Nexa" or the "Company") (NYSE Symbol:NEXA) is pleased to announce that Cerro Lindo has resumed its operations. The road access has been restored. However, some drainage systems are still being repaired.

The plant is currently operating according to our production plan, 17ktpd, while the underground mine dewatering process is progressing as planned and is expected to be completed within 15 days.

Cerro Lindo produces approximately 233t of zinc per day. The 1Q23 production loss is expected to be recovered in the upcoming quarters. The 2023 guidance remains unchanged as of the date of this press release.

## About Nexa

Nexa is a large-scale, low-cost integrated zinc producer with over 60 years of experience developing and operating mining and smelting assets in Latin America. Nexa currently owns and operates five long-life mines - three located in the Central Andes of Peru and two located in the state of Minas Gerais in Brazil - and it is ramping up Aripuanã, its sixth mine in Mato Grosso, Brazil.

Nexa was among the top five producers of mined zinc globally in 2022 and one of the top five metallic zinc producers worldwide in 2022, according to Wood Mackenzie.
