

ReconAfrica Responds To Notice Of Civil Claim

VANCOUVER, May 26, 2023 - [Reconnaissance Energy Africa Ltd.](#) (the "Company" or "ReconAfrica") (TSXV: RECO) (OTCQX: RECAF) (Frankfurt: OXD) reports that on May 23, 2023, a shareholder of the Company, filed a claim pursuant to the Class Proceedings Act against the Company, in the Supreme Court of British Columbia, alleging various misrepresentations published in core and non-core documents.

ReconAfrica will review the claim, but currently has no reason to believe that there is any merit to the claim.

ReconAfrica is a Canadian oil and gas company engaged in the opening of the newly discovered deep Kavango Sedimentary Basin in the Kalahari Desert of northeastern Namibia and northwestern Botswana, where the Company holds petroleum licences comprising ~8 million contiguous acres.
