Nighthawk is a Canadian-based gold exploration and development company with 100% ownership of more than 947 km<sup>2</sup> District Scale Property within 200 km north of Yellowknife, Northwest Territories, Canada. The Colomac Gold Project PEA<sup>1</sup> demonstrates a potential large-scale gold operation of 290,000oz/year per year over 11.2-year conceptual mine life that generates a C\$1.2 billion after-tax NPV<sub>5%</sub> and 35% IRR (after taxes) based on a US\$1,600/oz gold. Nighthawk's experienced management team, with a track record of successfully advancing projects and operating mines, is working towards rapidly advancing its assets towards a development decision.
