

# Resouro Announces Increase in Offering Size of Brokered Private Placement

Toronto, June 27, 2023 - [Resouro Gold Inc.](#) (TSXV: RAU) ("Resouro" or the "Company") is pleased to announce that it has increased the size of its brokered private placement of common shares of the Company ("Shares") at a purchase price of \$0.15 per Share as previously announced on May 23, 2023, such that the Company now intends to issue 13,333,333 Shares for aggregate gross proceeds of up to \$2,000,000 (the "Offering").

The net proceeds from the Offering will be used to advance exploration on the Company's Tiros Titanium-REE Project and Novo Mundo Gold Project in Brazil and for general working capital purposes.

Closing of the Offering is expected to occur shortly and is subject to certain customary conditions, including, but not limited to, the receipt of all necessary approvals including the approval of the TSX Venture Exchange.

The securities offered have not been registered under the United States Securities Act of 1933, as amended, and may not be offered or sold in the United States or to, or for the account or benefit of, U.S. persons absent registration or an applicable exemption from registration requirements.
