

Antioquia Gold Cisneros Operations Update

Calgary, July 6, 2023 - [Antioquia Gold Inc.](#) (TSXV: AGD) (OTC Pink: AGDXF) ("Antioquia Gold", the Company or the "Corporation") is pleased to provide a summary of June 2023 production results for its Cisneros mining operation, and to announce the progress of other ongoing projects.

Production Summary and Operations Update:

During June, 3,428 troy ounces of gold were produced at the Cisneros mining operation, with a recovery of gold to concentrate of 97.43% during the month.

Third Party Mineralized Material: During June, 1,831 tonnes of third-party mineralized material with an average gold grade of 12.49 g/t were purchased, representing 20% of the monthly gold production.

Mr. Gonzalo De Losada, CEO of Antioquia Gold, stated "After facing three months of challenges related to environmental authority issues and limited tailings storage capacity, we have successfully resolved these challenges and restored normal operations. Currently, our process plant is operating at full capacity, and we are optimistic about a more favorable second semester after overcoming these hurdles."

Readers should be cautioned that the Corporation's decision to move forward with the construction and production of the Cisneros Mine is not based on the results of any pre-feasibility study or feasibility study of mineral resources demonstrating economic or technical viability. Since 2013, the Corporation has undertaken exploration and development activities; and after taking into consideration various factors, including but not limited to: the exploration and development results to date, technical information developed internally, the availability of funding, the low starting costs as estimated internally by the Corporation's management, the Corporation is of the view that the establishment of mineral reserves, the commissioning of a pre-feasibility study or feasibility study at this stage is not necessary, and that the most responsible utilization of the Corporation's resources is to proceed with the development and construction of the mine. Readers are cautioned that due to the lack of pre-feasibility study or feasibility study, there is increased uncertainty and higher risk of economic and technical failure associated with the Corporation's decision. In particular, there is additional risk that mineral grades will be lower than expected, the risk that construction or ongoing mining operations will be more difficult or more expensive than management expected. Production and economic variables may vary considerably, due to the absence of a detailed economic and technical analysis in accordance with NI 43-101. Project failure may materially adversely impact the Corporation's future profitability, its ability to repay existing loans, and its overall ability to continue as a going concern.
