

# Highlander Silver Announces Effective Date for Share Consolidation

Vancouver, October 12, 2023 - [Highlander Silver Corp.](#) (CSE:HSLV) (the "Company" or "Highlander Silver") announces that, further to its news release on October 3, 2023, effective at the opening of trading on October 17, 2023 (the "Effective Date") the common shares of the Company (the "Shares") will commence trading on the Canadian Securities Exchange on a consolidated basis, with one post-consolidated Share outstanding for every two pre-consolidation Shares (the "Consolidation").

As a result of the Consolidation, on the Effective Date, a total of approximately 30,460,433 Shares will be issued and outstanding, subject to adjustments for rounding, with approximately 1,450,000 Shares reserved for issuance. No fractional shares will be issued. The number of post-consolidated Shares to be received will be rounded up to the nearest whole number for fractions of 0.5 or greater or rounded down to the nearest whole number for fractions of less than 0.5.

The exercise or conversion price and the number of Shares issuable under any of the Company's outstanding convertible instruments will be proportionately adjusted upon the effectiveness of the Consolidation.

Shareholders of record as of the Effective Date who hold Shares represented by a physical certificate or DRS statement will receive a letter of transmittal from the transfer agent for the Company, National Securities Administrators Ltd., with instructions on how to exchange their existing certificates or DRS statements for certificates or DRS statements representing Shares on a post-Consolidation basis.
