

Signal Gold Announces Upsize to Previously Announced Private Placement for up to \$2.72 Million and Completes Another Tranche of Financing

TORONTO, December 5, 2023 - [Signal Gold Inc.](#) ("Signal Gold" or the "Company") (TSX:SGNL)(OTCQX:SGNLF) is pleased to announce that it has upsized its previously announced non-brokered private placement to now raise gross proceeds of up to \$2,720,000 (the "Offering"). The Offering will now consist of up to 1,266,666 units of the Company (the "Units") at a price of \$0.15 per Unit, and up to 14,882,447 "flow-through" units of the Company (the "FT Units") at a price of \$0.17 per FT Unit. Each Unit will consist of one common share in the capital of the Company ("Common Share") and one-half of one Common Share purchase warrant (each whole Common Share purchase warrant, a "Warrant"). Each FT Unit will consist of one Common Share to be issued as a "flow-through share" as defined in subsection 66 (15) of the Income Tax Act (Canada) and one-half of one Warrant, to be issued on a non-flow-through basis.

The Company is also pleased to also announce that it has completed another tranche of the Offering for aggregate gross proceeds of \$700,000 pursuant to which the Company issued 7,764,800 FT Units. The Company has received gross proceeds of \$2,530,016 to date under the Offering, which will be used to advance growth exploration activities at the Goldboro Project.

Any securities issued under the Offering will be subject to a hold period of four months and a day from the applicable closing date of the Offering in accordance with the rules and policies of the Toronto Stock Exchange ("TSX"), and applicable Canadian securities laws and such other further restrictions as may apply under foreign securities laws. The Offering remains subject to the approval of the TSX.

The securities offered have not been registered under the U.S. Securities Act of 1933, as amended, and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements. ABOUT SIGNAL GOLD

Signal Gold is advancing the Goldboro Gold Project in Nova Scotia, a significant growth project subject to a positive Feasibility Study which demonstrates an approximately 11-year open pit life of mine ("LOM") with average gold production of 100,000 ounces per annum and an average diluted grade of 2.26 grams per tonne gold. (Please see the 'NI 43-101 Technical Report and Feasibility Study for the Goldboro Gold Project, Eastern Goldfields District, Nova Scotia' on January 11, 2022, for further details). On August 3, 2022, the Goldboro Project received its environmental assessment approval from the Nova Scotia Minister of Environment and Climate Change, a significant regulatory milestone which enables the Company to commence site-specific permitting processes including the Industrial Approval and Crown Land Lease and Mining Lease applications. The Goldboro Project also has potential for further Mineral Resource expansion, particularly towards the west along strike and at depth. A future study will consider upgrading and expanding potentially mineable underground Mineral Resources as part of the longer-term mine development plan.
