

Bulgold Inc. Announces Filing of Fourth Quarter Financial Results for Three and Twelve Months Ended December 31, 2023

TORONTO, April 23, 2024 - [Bulgold Inc.](#) (TSXV: ZLTO) (the "Company" or "BULGOLD") is pleased to announce that it has filed its audited condensed interim financial statements and MD&A for the fourth quarter and year ended December 31, 2023. During the three months ended December 31, 2023, the Company incurred a net loss of \$264,578 (\$0.01 per share). For the year ending December 31, 2023, the company incurred a net loss of \$1,873,160 (\$0.08 per share), including a non-cash expense of \$734,269 being the cost of listing (the cost of listing relates to the recently completed acquisition of assets in Bulgaria). Other expenses incurred, primarily related to professional fees for the completion of the acquisition. On December 31, 2023, the company had cash (and cash equivalents) of \$2,015,716 (net working capital of \$1,486,855) which will be used to support exploration activities.

About Bulgold Inc.

BULGOLD is a gold exploration company focused on the exploration and development of mineral exploration projects in Central and Eastern Europe. The Company controls 100% of three quality quartz-adularia epithermal gold projects located in the Bulgarian and Slovak portions of the Western Tethyan Belt: the Lutilla Gold Project, the Kostilkovo Gold Project and the Kutel Gold Project. Management of the Company believes that its assets show potential for high-grade, good-metallurgy, low-sulfidation epithermal gold mineralisation.
